



II Photography International Contest “Humanization of Health Care”

Contest Rules

The organizing committee conformed by the “Federación Peruana de Administradores de Salud – FEPAS”, the “Federación Andina y Amazónica de Hospitales y Servicios de Salud – Sede Perú”, the “Asociación Peruana de Hospitales y Servicios de Salud” and the “Sociedad Latinoamericana de Hotelería Hospitalaria”, invite to participate at the 2nd International Photography Contest “Humanization of Health Care”, being held at Lima-Peru.

This contest has an international character, intended to the general public, in the categories of amateur and professional photographer, and focused on the internal and external users, hospital support services, strange or orphan sicknesses, the age of knowledge (elder adults) and natural disasters.

Everyone together at health, working for the construction of an every time better society, with strengthening of the humanization of care in health services, with intercultural management, respect of the worldview and of the beliefs related to the health – sickness process, like Andean, Amazonian, Afro and Asian descendants, staring at the individual as mind, body, soul and valuing the selfless work of caring for another human being.

Article One. Of the Contestant

The contest is open, on international level and has two categories:

- **Amateur Photographer category**
- **Professional Photographer category**

This contest has no distinction on nationality or residence place. Identification with an identity document: DNI or passport.

Organizers or jurors’ direct relatives cannot participate on the contest.

Article Two. Of the inscriptions

The inscription will be held from 2017s’ May 15th to August 31th of the same year.

Article Three. Of the organization

Organized by the “Federación Peruana de Administradores de Salud – FEPAS” and institutions of health and Civil Society.

Article Four. Of the features of the photograph

The work must be presented on a sealed and labeled envelope with:

- Affair: II International Photography Contest of the health sector “Humanization of Health Care”
- Contestants' Category
- Title of the photographic work
- Review of the photographic work
- Pseudonym
- Used technic
- Postal address
- Email and the authors' telephone

Every author must participate with a single picture with the following characteristics according to the contestants' category:

Category: Amateur Photographer

- On physic: Photographic work with a measure of 20x30 cm. (Send without montage)
- On digital: JPG format and a minimum size of 2MB.
- The Photography will come with a title and s review.

Category: Professional Photographer

- On physic: Photographic work with a measure of 20x30 cm. (Send without montage)
- The work will be presented on .jpg digital format with a minimum of 1240px on its minor side.
- The photograph will come with a title and a review.
- A Curriculum Vita which validates your professional photographer condition, it just has to have one page.

The contests' work shouldn't be on pending vote nor have been awarded on another contest. Being this the case, the author will be immediately disqualified.

If the photographs that compete correspond to frontal images of internal or external adult users from the health systems – patients do obtain the corresponding informed consent; if the photographs are from children, it should have their parents' consent.



Article Five. Of the contests' coordinator

A professional photographer, representative of the “Federación Peruana de Administradores de Salud – FEPAS” will coordinate the Photography contest.

Article Six. Of the contests' theme

The photographs presented should adequate to the message of humanization on health care and could be focused to:

- Internal users: human talent on health
- External users: patients, relatives, general users of the health system
- Hospital Hospitality: concept, hospitalary management on the hospitals
- Warriors and weird or orphan sicknesses: patients' roles, relatives, leaders on weird or orphan sicknesses
- The age of knowledge: focused on elder adults

Article Seven. Of the jurors

The jurors will be conformed by three expert professionals on photography, two health professionals, representatives from national and international institutions and two representatives from civil society. The qualifier juror, an expert professional on photography, is the one directing.

Article Eight. Photographic works selection

Up to twenty photographs will be selected corresponding to each category: Amateur and Professional Photographers.

The twenty contestants selected will participate on a collective exposition, in the development framework of the “V Congreso FEPAS” being held from 2017s' November 6th to 8th at the region Callao.

The twenty contestants will be told of the results on 2017s' Friday October 6th.

Article Nine. Of the results

From these twenty selected, three prices will be chosen on each category: Golden prize, Silver prize and Bronze prize, on 2017s' Tuesday November 7th. Any other theme not seen on the Contest Rules will be solved by the organizers.

Article Ten. Of the prizes

Amateur Photographers Category:

- First place:
 - Gold prize
 - Diploma
 - FEPAS prize
 - “Sociedad Latinoamericana de Hotelería Hospitalaria” prize.

 - Silver medal and diploma
- Third place:
 - Bronze medal and diploma

Professional Photographers Category:

- First place:
 - Gold prize
 - Diploma
 - FEPAS prize
 - “Sociedad Latinoamericana de Hotelaría Hospitalaria” prize.
- Second place:
 - Silver medal and diploma
- Third place:
 - Bronze medal and diploma

Article Eleven. Of the photographs exposure

The prized photographs and a selection of the rest of the contestant photographs will be able to be appreciated on an exposition that will be held on the Callao Region, hospitals and institutes from Lima.

Article Twelve. Consent on the use of the photographic work

The contestants of the Photographic contest consent that the photographs presented on the contest can be used by the organizers on cultural and social effects without it meaning any payment nor consideration to the authors; mentioning in all cases the title and authors' name, who keeps the hold of the rights of intellectual property.

Article Thirteen. Return of the Photographic works
